MILL BAY WATERWORKS DISTRICT BYLAW NO. 302 Parcel Tax 2024

A bylaw for imposing taxes upon the assessed lands in the Mill Bay Waterworks District for 2024 and to provide a percentage addition to encourage prompt payment thereof.

The Trustees of the Mill Bay Waterworks District **ENACT AS FOLLOWS**:

- 1. That for the year 2024 there are hereby levied the following taxes:
 - A-1) A tax of \$323.13 per parcel on all parcels of land classified into Group A-1 on the Assessment Roll.
 - A-2) A tax of \$323.13 per parcel on all parcels of land classified into Group A-2 on the Assessment Roll.
 - B-1) A tax of \$528.67 per parcel on all parcels of land classified into Group B-1 on the Assessment Roll.
 - B-2) A tax of \$1,057.32 per parcel on all parcels of land classified into Group B-2 on the Assessment Roll.
 - B-3) A tax of \$2,643.29 per parcel on all parcels of land classified into Group B-3 on the Assessment Roll.
 - B-4) A tax of \$4,229.27 per parcel on all parcels of land classified into Group B-4 on the Assessment Roll.
 - B-5) A tax of \$5,815.24 per parcel on all parcels of land classified into Group B-5 on the Assessment Roll.
 - C) There shall be no tax on any parcels classified into Group C on the Assessment Roll.
 - D) There shall be no tax on any parcels classified into Group D on the Assessment Roll.
- 2. Parcel Taxes are applied to each property in the Mill Bay Waterworks District as per the legal category of land use and described in the MBWD Assessment Bylaw 273. Landowners must notify MBWD if there is a change in land use.
- 3. That the aforementioned taxes shall be due and payable on or before the twenty eighth (28th) day of June 2024 and a percentage addition of 18% of the amount thereof shall be added to all taxes remaining unpaid after the said date.
